This announcement is made pursuant to Rule 13.10(B) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Datang International Power Generation Co., Ltd. (the "Company") announces that, based on the Company's preliminary statistics, as of 31 December 2015, total power generation of the Company and its subsidiaries (the "Group") amounted to approximately 169.7252 billion kWh, representing a decrease of approximately 10.12% when compared to the corresponding period of the previous year. Total ongrid power generation of the Group amounted to approximately 160.8296 billion kWh, representing a decrease of approximately 9.97% when compared to the corresponding period of the previous year.

As affected by the surplus balance of nationwide power demand and supply in general and the decrease in regional on-grid utilisation hours where the thermal power generating units of the Group were located, the power generation of thermal power generating units and the on-grid power generation decreased by approximately 11.55% and 11.50%, respectively, when compared with the corresponding period of the previous year. The power generation of the Group's hydropower generating units and the on-grid power generation increased by 0.17% and 0.75%, respectively, when compared with the corresponding period of the previous year as a result of factors

including the increase in capacity of hydropower generating units. Since the capacity of the Group's wind power generating units were enhanced, power generation of the Group's wind and photovoltaic generating units and the on-grid power generation increased by approximately 2.49% and 2.61%, respectively, when compared with the corresponding period of the previous year.

As of 31 December 2015, the average on-grid tariffs of the Company was RMB406.27 per MWh.

Note: The Company and Chalco Ningxia Energy Group Co., Ltd. entered into the relevant agreement, agreeing that the financial statements of Ningxia Datang International Daba Power Generation Company Limited ("Daba Power Company") would be consolidated by rotation for every three years. Pursuant to the agreement, the financial statements of Daba Power Company will be consolidated into that of Chalco Ningxia Energy Group from 1 January 2015 to 31 December 2017. Therefore, the power generation of the Company for the year 2015 did not include the power generation and the on-grid power generation of Daba Power Company.

II. Status of capacity increase for the year of 2015

Installed capacity of the Company for the year of 2015 increased by 2,195.88MW in total, the breakdown of which is as follows: an increase in newly-installed capacity of thermal power generating units of 1,000MW (No.1 unit of Jiangxi Datang International Fuzhou Power Generation Company Limited commenced operation on 29 December 2015), an increase in newly-installed capacity of wind power generating units of 149.5MW and an increase in newly-installed capacity of hydropower generating units of 1,046.38MW.

III. Status of the power generation projects approved

For the year of 2015, the Company has obtained official approvals for projects with a total capacity of 9,488.5MW, including thermal power projects with a total capacity of 8,864MW, wind power projects with a total capacity of 479.5MW, photovoltaic projects with a total capacity of 100 MW and hydropower capacity expansion projects with a capacity of 45MW. Details were as follows:

- 2. Wind power project: Datang International Zhejiang Pinghu 32MW wind power field project, Ningxia Datang International Qingtongxia Shashi Dunliang 48MW wind power field project, Jiangxi Datang International Wuning Taiyangshan 50MW wind power field project, Jiangxi Datang International Shicheng Jinhua Mountain 99.5MW wind power field project, Hebei Datang International Fengning Datan 200MW wind power field project, Shanxi Datang International Zuoyun Xiaojingzhuang 49.5MW wind power field project;

- 3. Photovoltaic projects: Phase III of Qinghai Geermu 50MW photovoltaic power generation project, Phase III of Qinghai Gonghe 10MW photovoltaic power generation project, Phase I of Hebei Fengning 20MW photovoltaic power generation project, Phase IV of Qinghai Gonghe 20MW photovoltaic power generation project;
- 4. Hydropower capacity expansion project: Chongqing Wujiang Yinpan 45MW hydropower capacity expansion.
