This announcement is made pursuant to Rule 13.10(B) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Datang International Power Generation Co., Ltd. (the "Company") announces that, based on the Company's preliminary statistics, as of 31 March 2016, total power generation of the Company and its subsidiaries (the "Group") amounted to approximately 35.9529 billion kWh, representing a decrease of approximately 9.42% when compared to the corresponding period of the previous year. Total on-grid power generation of the Group amounted to approximately 34.0212 billion kWh, representing a decrease of approximately 9.28% when compared to the corresponding period of the previous year.

As affected by the surplus balance of nationwide power demand and supply in general and the decrease in regional on-grid utilization hours where the thermal power generating units of the Group were located, the power generation of thermal power generating units and the on-grid power generation decreased by approximately 13.79% and 13.89%, respectively, when compared with the corresponding period of the previous year. The power generation of the Group's hydropower generating units and the on-grid power generation increased by 42.42% and 42.94%, respectively, when compared with the corresponding period of the previous year as a result of factors including the increase in total inflow of hydropower generating units. Due to the impact

from the factors including the increase in the capacity of the wind power generating units of the Group when compared with the corresponding period of the previous year and the increase in the average wind speed in the regions where such generating units locate, the power generation and the on-grid power generation of the wind power generating units increased by 6.70% and 6.68%, respectively, when compared with the corresponding period of the previous year; due to the increase in the capacity of the Group's photovoltaic power generating units, the power generation and the on-grid power generation of the photovoltaic generating units increased by approximately 10.94% and 11.41%, respectively, when compared with the corresponding period of the previous year.

As of 31 March 2016, the average on-grid tariffs of the Company were RMB383.43 per MWh.
