Datang International Power Generation Co., Ltd. (the "Company") announces that, based on the Company's preliminary statistics, as of 31 March 2017, total power generation of the Company and its subsidiaries (the "Group") amounted to approximately 44.2071 billion kWh, representing an increase of approximately 22.96% when compared to the corresponding period of the previous year. Total on-grid power generation of the Group amounted to approximately 41.7735 billion kWh, representing an increase of approximately 22.79% when compared to the corresponding period of the previous year.

As affected by the increased utilization hours of thermal power in the region where the Group is located, the Group recorded year-on-year increases of approximately 27.25% and 27.29%, respectively, in the power generation and the on-grid power generation of thermal power generating units. The Group recorded year-on-year decreases in the power generation and on-grid power generation of hydropower generating units of approximately 10.36% and 10.46%, respectively, as a result of the decrease in the water inflow of the drainage basin where part of hydropower generating units of the Group are located. The Group recorded year-on-year increases in the power generation and on-grid power generation of wind power generating units of approximately 17.66% and 17.86%, respectively, due to the year-on-year increase in the capacity of wind power generating units of the Group and other relevant factors. The Group recorded year-on-year increases in the power generation of photovoltaic

power generating units of approximately 35.34% and 34.49%, respectively, due to the year-on-year increase in the capacity of photovoltaic power generating units of the Group.

As of 31 March 2017, the average on-grid tariff of the Company was RMB377.03 per MWh.
