Datang International Power Generation Co., Ltd. (the "Company") announces that, based on the Company's preliminary statistics, as of 31 March 2018, total power generation of the Company and its subsidiaries (the "Group") amounted to approximately 48.728 billion kWh, representing an increase of approximately 10.23% when compared to the corresponding period of the previous year. Total on-grid power generation of the Group amounted to approximately 46.005 billion kWh, representing an increase of approximately 10.13% when compared to the corresponding period of the previous year.

As affected by the increased utilization hours of thermal power and a year-on-year increase in the installed capacity of thermal power generating units and other relevant factors in the region where the Group is located, the Group recorded year-on-year increases of approximately 8.10% and 7.87%, respectively, in the power generation and the on-grid power generation of thermal power generating units. The Group recorded year-on-year increases in the power generation and on-grid power generation of hydropower generating units of approximately 29.30% and 29.42%, respectively, as a result of the and other relevant factors year-on-year increase in the installed capacity of hydropower generating units of the Group. The Group recorded year-on-year increases in the power generating units of approximately 23.94% and 24.22%, respectively, due to the year-on-year increase in the capacity of wind power generating units of the Group, the increase in the utilisation rate of wind power and other relevant factors. The Group recorded year-on-year increases in the power generation and on-grid power generation of photovoltaic power generating units of approximately 28.88% and 29.05%, respectively, due to the year-on-year increase in the capacity of photovoltaic power generating units of the Group and other relevant factors.

As of 31 March 2018, the average on-grid tariff of the Company was RMB383.06 per MWh.
